1. Overview

Important: Tivev does **not** issue airline tickets, collect payment for flights, or act as a seller of travel. All bookings are completed through external providers or agencies.

3. Use of the Platform

3.1 Eligibility

You must be at least 18 years old and legally capable of entering into a binding contract to use TIvev. Use of the platform is intended for business and professional purposes only.

3.2 Account Access

Access to certain features of Tivev may require a paid subscription. You are responsible for keeping your login credentials secure and for all activity under your account.

4. Subscription Plans and Billing

Access to TIvev is offered on a subscription basis:

• Pro Plan: \$200/month per user

• Enterprise Plan: Custom pricing starting at \$10,000/month

Plans include unlimited searches, access to exclusive fare data, and other advanced features depending on your subscription tier.

4.1 Free Trial

We offer a free trial to eligible users. Trial access may be limited and subject to change without notice.

4.2 Billing and Renewal

Subscriptions are billed monthly or annually depending on your plan. Unless canceled, your subscription will automatically renew. No refunds are issued for partial billing periods.

5. Third-Party Content and Services

Tivev provides access to airfare data from third parties. We do not guarantee the accuracy, availability, or completeness of this data. Any booking, fare purchase, or transaction is conducted outside of Tivev with the respective provider.

We are not responsible for changes, cancellations, or disputes arising from bookings made based on fare data shown on Tivev.

6. User Responsibilities

You agree not to:

- Misuse, reverse engineer, or copy any part of the Platform.
- Use Tivey to resell access without authorization.

- Use automated tools to scrape or extract data from the Platform.
- Circumvent access restrictions or violate any applicable laws.

7. Intellectual Property

All content, algorithms, and technology used in Tivev are owned by or licensed to Easy Travel LLC. You are granted a non-exclusive, non-transferable license to use the Platform solely for your internal business use.

8. Limitation of Liability
